SAP LeanIX Store Terms of Use

The SAP LeanIX Store is a web shop, for purposes of these terms called "SAP LeanIX Store" which allows you and other users, and other interested parties ("You" or "Your") to use the information, application or integrations created and published by SAP (the "SAP Contents") and/or third parties ("Partner Contents"), including but not limited to text, images, photographs, graphics, audio and video, data, code, and software (together "Contents"). Furthermore, the SAP LeanIX Store serves as a marketing and distribution platform for SAP companies as well as Partners. Your access and use of the SAP LeanIX Store is subject to the Terms of Use for SAP Websites in addition to the SAP LeanIX Store specific terms and conditions listed below.

Accessing or licensing of any Content offered on the SAP LeanIX Store is NOT available for consumers, but solely for merchants/corporations and require an existing SAP Software. If you are accessing and/or using the SAP Websites on behalf of your employer or as a consultant or agent of a third party (collectively, "your Company"), you represent and warrant that you have the authority to act on behalf of and bind your Company to the terms of this SAP LeanIX Store Terms of Use, and everywhere these SAP LeanIX Terms of Use refer to you or your, shall also include your Company. Appendix A – SAP LeanIX Store specific terms and conditions



1. Your information, privacy, and data protection

Where SAP through the SAP LeanIX Store temporarily collect and utilize personal information provided by You for the purposes of processing a license or access contract for SAP products or products of Partners, collection and processing of such personal information will be treated in compliance with <u>SAP Privacy Statement</u>, the Federal German Data Protection Act (Bundesdatenschutzgesetz), and other applicable legislation. You agree that SAP may access, preserve and disclose Your personal information and/or Content if required to do so by law or to:

- 1. comply with a legal process;
- 2. respond to claims that any Content violates the rights of third parties or
- 3. protect the rights, property or personal safety of SAP, users of the SAP LeanIX Store, and the public or enable the SAP LeanIX Store to process business transactions (access/licensing of products) between You and a Partner.

You explicitly agree that such information is provided to the respective Partner for the purposes of delivery/distribution and licensing of such Partner Content.

You agree to comply with the terms of the SAP Privacy Statement.

2. Permissible use of the SAP LeanIX Store

You agree not to access or utilize the SAP Content or access the SAP LeanIX Store for purposes that are inconsistent with SAP's legitimate business interests. 4. Applicable law for SAP LeanIX Store

The SAP LeanIX Store is created and controlled by SAP SE in Germany. Therefore, the laws of Germany will govern this SAP LeanIX StoreTOU without giving effect to any principles of conflicts of laws. You also agree to comply with all laws from the country in which You reside that are applicable to the transmission of data on the Internet, including, but, not limited to laws governing the use of encryption and laws governing the transmission of data across international boundaries, into prohibited countries, and containing personally identifiable information.
